Introduction to parent company



- **China Resources (Holdings) Co. Ltd.** (hereinafter "CR") is a multi-business holding enterprise group registered and operating in Hong Kong. Its predecessor was Liow & Company established in Hong Kong in 1938 and was renamed China Resources Company in 1948.
- In **2018**, CR realised a total turnover of **USD86.1 billion**, a total profit of **USD10.3 billion** and a total asset of **USD190.8 billion**. As one of the Global 500 in the world, **CR** was ranked the **86th** of the Global 500 by Fortune in 2018.



CRL & Farenco - History

- China Resources Logistics (Groups) (CRL), whose predecessor Far East Enterprising Co.,(H.K.) Limited (FARENCO), was founded in HK in 1948.
- CRL is wholly-owned by China Resources Enterprise Limited (CRE) since 2003 .
- Farenco Freight Services Ltd. (FFS) is the Integrated Logistics Division of CRL. The core business includes third-party logistics for industrial products and consumer goods, as well as freight forwarding services.

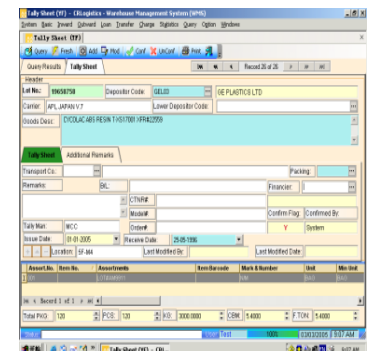

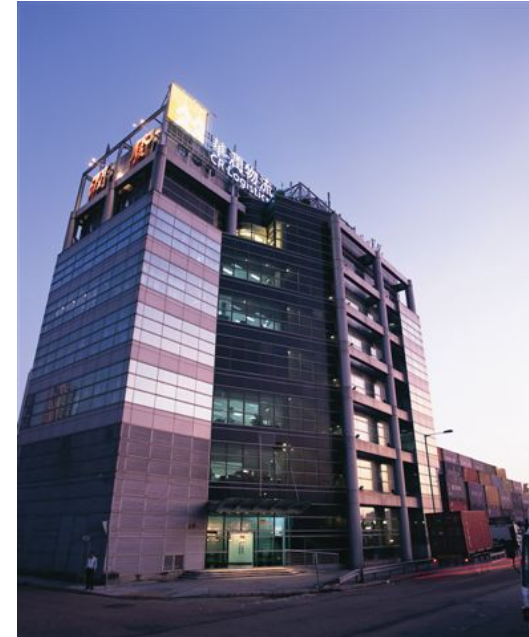
